I, the undersigned, hereby acknowledge and agree that all the information provided in this Grooming/Pet sitting/Playtime Application is Complete and accurate to the best of my knowledge. I further acknowledge and agree I have read, understand Liability, and agree to all terms and conditions contained in the Grooming Policies, Procedures, and Release, Waiver of Assumption of Risk and Indemnification Agreement (the "Agreement"), as they may be amended from time to time, which are attached and fully incorporated in to this application by reference. I hereby execute the Agreement for my dog, myself and my heirs, successors, representative and assigns. I further attest that if I am not the sole owner or representative of the dog subject to this application that my signature is sufficient to enter into this Agreement for and on behalf of any other owner or representative.

WARNING, PLEASE READ CAREFULLY. THIS AGREEMENT INCLUDES A RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS AND DEPRIVES YOU OF THE RIGHT TO SUE The Dog Loft L.P. AND RELATED PARTIES. DO NOT SIGN THIS AGREEMENT UNLESS YOU HAVE READ IT IN ITS ENTIRETY. SEEK THE ADVICE OF LEGAL COUNSEL IF YOU ARE UNSURE OF ITS EFFECT. GROOMING POLICIES, PROCEDURES AND DOGS RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT.

In consideration for my Dog being permitted to be a client at The Dog Loft L.P. I make the following representations and Agree to all of the following policies, procedures, terms and conditions: 1. CONSENT. I entrust my pet to The Dog Loft L.P. for the Purpose of grooming my dog. I understand and am aware that all due care will be taken with my dog for the safety of the dog and the groomer. I am aware that neglect of my dog's coat can be a cause for problems after grooming such as clipper/brush irritation. If my dog is wiggly or doesn't remain still during grooming, accidents can happen such as nicks/scrapes from clippers or scissors. 2. MATTED COAT. I am aware that if my dog's coat is matted, I have the following three (3) options: A. I can brush the coat out and return at a later time for grooming. B. The Dog Loft L.P. will de-mat my dog for \$10--\$35 in addition to the regular grooming fee if it does not overly stress dog out. I understand that time and costs associated with de--matting are unpredictable and subject to the particular condition of the Dog. C. Request a shave down and start over. Additional fees may apply. 3. PERSONAL PROPERTY. I agree that The Dog Loft shall not be responsible or liable for any lost, stolen, or damaged personal property belonging either to my Dog or me. I also understand and agree that my Dog's collar may be removed in the grooming area to prevent injury to any Dog. 4. RIGHT TO REFUSE SERVICE.

The Dog Loft has the right to refuse service for any reason it deems. In the event of a Dog that cannot be groomed safely without danger to the groomer/employees/ or others, The Dog Loft will use muzzles, e--collars, slings, straps, etc. Grooming services may be stopped mid--groom if necessary for the safety of the Dog or groomer. Grooming fees may still be applied 5. ABANDONED DOGS. The Dog Loft is a place where all Dogs loved can exercise and play. No Dog may be abandoned at The Dog Loft. I agree that I will not neglect to pick up my Dog from Grooming/Pet sitting by the time he/she is scheduled to leave without providing notification. Any Dog that is left at The Dog Loft without any contact, instruction or notification time from me, of the ability, willingness or plans to pick him/her up by myself or my personal representative or agent, will be considered abandoned Upon the third day of such notification failure. I understand that if I abandon my Dog at The Dog Loft, The Dog Loft will, by default, become the legal owner and guardian of the Dog. The Dog Loft will, in its sole discretion, determine whether to try to rehome and adopt the Dog from The Dog Loft location at which he/she was abandoned or will relinquish the Dog to an unrelated shelter of its choice.

I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY DOG AT THE DOG LOFT. I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY DOG AND WILL HAVE NO RECOURSE AGAINST THE DOG LOFT AS PROVIDED FOR BELOW. 6. DOG PHOTOS AND VIDEO RELEASE. I Agree to allow any The Dog Loft location, its owners, employees, officers, directors and agents to use my Dog's name and any images or likeness of my Dog taken while he/she is a Dog at Camp, in any form or format, for use, at any time, in any media, marketing, advertising, illustration, trade or promotional materials. I agree that this provision shall be binding on me and all of my successors, heirs, legal representatives and assigns. 7. DUTY TO DISCLOSE. I have disclosed and will continue to disclose on an ongoing basis, any and all medical or other conditions, including but not limited to personality concerns or behaviors that may affect, limit or prevent my Dog's ability to participate in play time or otherwise attend The Dog Loft. 8. ACCPETANCE AND ACKNOWLEDGEMENT OF PLAYTIME PARTICIPATION RISK. I FULLY UNDERSTAND THAT; (a) THERE ARE INHERENT AND POTENTIAL RISK INVOLVED WITH INTERACTIONS BETWEEN HUMANS AND DOGS, AS WELL AS BETWEEN DOGS AND OTHER DOGS, WHICH MAY RESULT IN PROPERTY DAMAGE OR BODILY INJURY, INCLUDING BUT NOT LIMITED TO, SCRATCHES, CUTS, BITES, PERMANENT DISABILITLY, SICKNESS OR DEATH TO HUMAN OR DOG; AND (b) THERE MAY BE OTHER RISKS NOT KNOWN TO ME NOR READILTY FORSEEABLE AT THIS TIME (COLLECTIVELY, "RISK"). I FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILTY FOR ALL RISKS, INCLUDING, WITHOUT LIMITATION, ALL LOSSES, COSTS AND DAMAGES INCURRED AS A RESULT OF MY DOG'S PARTICIPATION IN Playtime, INCLUDING ANY VETERINARIAN EXPENSES INCURRED ON BEHALF OF MY DOG. SICKNESS SHALL BE DEFINED TO INCLUDE ANY ILLNESS INCLUDING BUT NOT LIMITED TO BORDETELLA (KENNEL COUGH) OR ANY OTHER FORM OF CONTAGIOUS ILLNESS. 9. VETERINARIAN LIABILITY AND CARE. I agree to allow The Dog Loft to obtain medical treatment for my dog, if, in its sole discretion it appears that, he/she is ill, injured or exhibits any other behavior that would reasonably suggest that my Dog may need medical treatment. I AGREE THAT I AM FULLY RESPONSIBLE FOR THE COST OF ANY SUCH MEDICAL TREATMENT, AND FOR THE COST OF ANY TRANSPORTATION FOR THE PURPOSES OF SUCH TREATMENT, PROVIDED TO MY DOG. 10. WAIVER, RELEASE AND INDEMNIFICATION. I HEREBY AGREE TO EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS, AND DEFEND THE DOG LOFT THEIR INVITEES, SPONSORS, ADVERTISERS, OWNERS, OFFICERS, DIRECTORS, EMPLOYEES, VOLUNTEERS, AGENTS, REPRESENTATIVES, LEASORS, AND ALL OTHERS HAVING INTEREST IN THE DOG LOFT (THE "RELEASES) FROM AND AGAINST ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES, DAMAGES, ATTORNEY'S FEES, EXPENSES OR DEMANDS OF EVERY CHARACTER WHATSOEVER ON THE ACCOUNT OF, ARISING OUT OF, RESULTING FROM OR RELATING IN ANY WAY TO (I) ANY ACT OR OMISSION OF THE RELEASEES, INCLUDING NEGLIGENCE, AND (II) MY OR MY DOG'S PARTICIPATION IN PLAYTIME, OR OTHERWISE. I AGREE THAT THIS RELEASE SHALL BE BINDING ON ME AND MY SUCCESSORS, HEIRS, LEGAL REPRESENTATIVES, AND ASSIGNS. I ALSO EXPRESSLY AND FOREVER RELEASE WAGTIME FROM ANY DUTY TO PROTECT ME OR MY DOG(S) FROM INJURY OF ANY KIND, AND AGREE THAT EVEN IF THE DOG LOFT CHOOSES TO IMPLEMENT SAFETY PRECAUTIONS, SUCH ACTIONS SHALL NOT ALTER THE FACT THAT I HAVE RELEASED THE DOG LOFT FROM ANY DUTY TO PROTECET ME OR MY DOG(S)

I HAVE READ AND FULLY UNDERSTAND THE TERMS OF THIS "GROOMING POLICIES, PROCEDURES AND DOG RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT" (THE "AGREEMENT) AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF LIABILITY TO THE GREATEST EXTENT PERMITTED BY THE LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID OR UNENFORCEABLE, THE REMAINDER OF THIS AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECT. I AGREE THAT IT IS INTENDED THAT ALL TERMS OF THIS AGREEMENT CONTROL DESPITE ANY PARTICULAR STATUE OR LAW THAT WOULD OTHERWISE PROTECT ME OR MY DOG(S).
